**Safety and Liv: (Russell and Jess) Developing a plan to support the houseless neighbors in Sunnyside has 4 key components: 1. Garbage removal-Vincent 2. Hygeine-Hannah 3. Gear Drive-Ash 4. Finding and helping to organize sanctioned, safe camping areas-Vincent.**

Jan gave a great overview of the Sunnyside Neighborhood Emergency Team. Key takeaways: Make sure you are prepared for your own safety and that of everyone in your household, have a “family plan” of where to meet and communication channels, have enough food and water in an accessible place in case of emergency. Jan directed people to the NET resources on the website for extensive information on this topic. There is enthusiasm for this and Jan will continue to keep our NA informed.**
